Chemical identity: 5-AMINO-6-CHLOROPYRIDINE-3-BORONIC ACID, PINACOL ESTER

Section 4: First aid measures

4.1. Description of first aid measures

Skin contact: Remove all contaminated clothes and footwear immediately unless stuck to skin.

5.1. Extinguishing media
