4. FIRST-AID MEASURES

5. FIRE-FIGHTING MEASURES

Special precautions for fire-fighters:

Use water spray or fog; do not use straight streams. Dike fire-control water for later disposal; do not scatter the material. These substances will accelerate burning when involved in a fire. May ignite combustibles (wood, paper, oil, clothing, etc.). Runoff to sewer may create fire or explosion hazard. Containers may explode when heated. Move containers from fire area if you can do it without risk.

Special protective equipment for fire-fighters:

Wear positive pressure self-contained breathing apparatus (SCBA). Structural fire fighters' protective clothing provides limited protection in fire situations ONLY; it may not be effective in spill situations. 6. ACCIDENTAL RELEASE MEASURES

Personal precautions: Avoid contact with skin, eyes, and clothing. Keep people away from and upwind of spill/leak. Use spark-

proof tools and explosion-proof equipment. Remove all sources of ignition. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing (Section 8). Warn

unnecessary personnel to move away. Stop leak if you can do it without risk. Ensure adequate ventilation.

Isolate the hazard area and deny entry to unnecessary and unprotected personnel.

Emergency procedures: Prevent dust cloud. Do not clean-up or dispose except under supervision of a specialist. ELIMINATE all

ignition sources (no smoking, flares, sparks or flames in the immediate area). Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Warn personnel to move

away. Prevent entry into sewers, basements or confined areas; dike if needed.

Methods and materials for containment and cleaning up:

ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). Stop leak if without risk. Keep away from combustible materials, reducing agents, acids, metal powders, light, heat, and sources of ignition. Do not get water inside container Absorb with an inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material. Dike far ahead of spill; use dry sand to contain the flow of material. Ventilate the area.

Environmental precautions:

Keep away from living quarters. Environmental hazard. Do not let product enter drains. Prevent further leakage or spillage if safe to do so. Water runoff can cause environmental damage. Prevent entry into sewers, basements or confined areas; dike if needed.

7. HANDLING AND STORAGE

Precautions for safe handling: Avoid inhalation of vapor or mist. Manipulate under an adequate fume hood. Do not ingest. Avoid contact

with skin and eyes. Avoid contact with combustible material (wood, paper, oil, clothing...). Keep away from heat and sources of ignition.
