Subacute to chronic toxicity:

Corrosive materials are acutely destructive to the respiratory tract, eyes, skin and digestive tract. Eye contact may result in permanent damage and complete vision loss. Inhalation may result in respiratory effects such as inflammation, edema, and chemical pneumonitis. May cause coughing, wheezing, laryngitis, shortness of breath, headache, nausea and vomiting. Ingestion may cause damage to the mouth, throat and esophagus. May cause skin burns or irritation depending on the severity of the exposure. Absorption into the body may lead to the formation of methemoglobin, producing cyanosis, and marked fall in blood pressure leading to collapse, coma and possibly death. Onset may be delayed 2-4 hours or longer.

Additional toxicological information:

Swallowing will lead to a strong corrosive effect on mouth and throat and to the danger of perforation of esophagus and stomach.

To the best of our knowledge the acute and chronic toxicity of this substance is not fully known.

No classification data on carcinogenic properties of this material is available from the EPA, IARC, NTP, OSHA or ACGIH.
