4. FIRST-AID MEASURES

Ingestion:	Harmful if swallowed. Do not induce vomiting without medical advice. Call a physician or Poison Control Center immediately. Special precautions for fire-fighters:

Ensure adequate ventilation. Isolate the hazard area and deny entry to unnecessary and unprotected personnel.
Personal protective equipment:	Wear eye protection (splash goggles) and face protection (full length face shield). Lab coat. Dust respirator. Be sure to use a MSHA/NIOSH approved respirator or equivalent. Wear protective gloves (nitrile).
Emergency procedures:	Prevent dust cloud. ELIMINATE all ignition sources (no smoking, flares, sparks or flames in the immediate area). Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Warn personnel to move away. Prevent entry into sewers, basements or confined areas; dike if needed.

Methods and materials for containment and cleaning up:

ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). All equipment used when handling the product must be grounded. Stop leak if without risk. Ventilate the area. Absorb with an inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material.

Use only non-sparking hand tool when handling this product. Ground all equipment containing material. Take measures to prevent build up of electrostatic charge. Good general ventilation should be sufficient to control airborne levels. Keep container dry. Handle and open container with care. Wear suitable protective clothing, gloves and eye/face protection. When using do not eat, drink, or smoke. Keep away from sources of ignition.
Conditions for safe storage:	Keep containers tightly closed in a cool, well-ventilated place. Keep away from sources of ignition. Store and use away from heat, sparks, open flame, or any other ignition source. Store locked up. Keep away from incompatibles. Containers which are opened must be carefully resealed and kept upright to prevent leakage. Avoid prolonged storage periods. Store under inert gas (e.g. Argon). Moisture sensitive.
