It has also been reported that copper poisoning has lead to hemolytic anemia and accelerates arteriosclerosis., Damage to the eyes., May liberate 2,4-pentanedione upon decomposition. 2,4-Pentanedione has the following toxicological hazards: toxic, irritant, neurological hazard, teratogen, possible mutagen, target organ - thymus. In humans, 2,4-pentanedione is reported to cause contact dermatitis and contact urticaria.
