Those exhibiting substantial water reactivity will have stronger irritating properties and may be corrosive enough to cause severe burns. Some organic phosphorus compounds are cholinesterase inhibitors. Symptoms associated with these include muscle twitching, convulsions, flaccid paralysis, coma, respiratory failure. They can be highly paralytic.
Organic silicon compounds are generally of low toxicity. Those exhibiting moisture sensitivity may be strongly irritating or corrosive on contact.
