Animal studies suggest that soluble tungsten compounds have the potential for causing adverse health effects involving the gastrointestinal tract and central nervous system. These effects have not been observed in humans. Chronic exposure to tungsten compounds may result in permanent lung damage.

Inorganic bromides may produce depression, emaciation and in severe cases, psychosis and mental deterioration. Bromoderma, a bromide rash, often occurs when bromide inhalation or administration is prolonged. This rash is usually found on the face and resembles acne and furunculosis.

Subacute to chronic toxicity: No effects known.
