#### 4. First-aid measures

Inhalation

# 6. Accidental release measures

Methods and materials for containment and cleaning up

Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Keep combustibles (wood, paper, oil, etc.) away from spilled material. Ventilate the contaminated area. This product is miscible in water. Stop the flow of material, if this is without risk.

Large Spills: Wet down with water and dike for later disposal. Shovel the material into waste container. Minimize dust generation and accumulation. Prevent entry into waterways, sewer, basements or confined areas. Following product recovery, flush area with water.

Small Spills: Sweep up or vacuum up spillage and collect in suitable container for disposal.

Studies on workers in plants where perchlorates are manufactured have shown no thyroid abnormalities; various clinical studies are ongoing. Perchlorates occur naturally in trace amounts in

the environment, and are not classified as carcinogenic.
