SECTION 4: First aid measures

4.1. Description of first aid measures

SECTION 5: Firefighting measures

5.1. Extinguishing media

Suitable extinguishing media : Alcohol resistant foam. Carbon dioxide. Dry powder. Water spray. Use extinguishing media appropriate for surrounding fire.

Fire hazard : Thermal decomposition generates: Carbon oxides. Hydrogen bromide. Hydrogen fluoride.

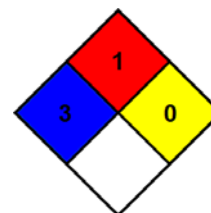
