4. FIRST-AID MEASURES

Inhalation:	Call emergency medical service. Move victim to fresh air. Give artificial respiration if victim is not breathing. Administer oxygen if breathing is difficult. Keep victim warm and quiet. Ensure adequate ventilation. Isolate the hazard area and deny entry to unnecessary and unprotected personnel.
Personal protective equipment:	Safety glasses. Lab coat. Dust respirator. Be sure to use a MSHA/NIOSH approved respirator or equivalent. Wear protective gloves (nitrile).

Methods and materials for containment and cleaning up:
