4. FIRST-AID MEASURES

Ensure adequate ventilation. Isolate the hazard area and deny entry to unnecessary and unprotected personnel.
Personal protective equipment:	Safety glasses. Lab coat. Dust respirator. Be sure to use a MSHA/NIOSH approved respirator or equivalent. Wear protective gloves (nitrile).
Emergency procedures:	Prevent dust cloud. ELIMINATE all ignition sources (no smoking, flares, sparks or flames in the immediate area). Methods and materials for containment and cleaning up:

ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). All equipment used when handling the product must be grounded. Stop leak if without risk. Ventilate the area. Absorb with an inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material.
