<b>Handling:</b>	This product should be handled only by, or under the close supervision of, those properly qualified in the handling and use of potentially hazardous chemicals, who should take into account the fire, health and chemical hazard data. A respiratory protection program that meets OSHA's 29 CFR 1910.134 and ANSI Z88.2 requirements must be followed whenever workplace conditions warrant a respirator's use.
<b>Other Protective:</b>	Facilities storing or utilizing this material should be equipped with an eyewash facility and a safety shower.
