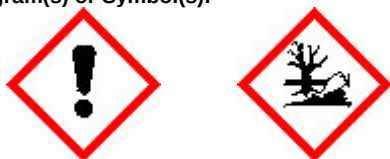

**Methods and materials for containment and cleaning up:**

Dike far ahead of spill; use dry sand to contain the flow of material.
