4.1. Description of first aid measures

5.1. Extinguishing media

5.2. Special hazards arising from the substance or mixture

Fire hazard : Thermal decomposition generates: Carbon oxides. Nitrogen oxides.

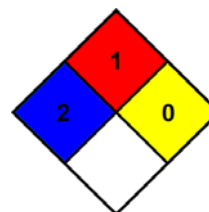
