5.2. Special hazards arising from the substance or mixture

Exposure hazards: Flammable. Harmful. Forms explosive air-vapour mixture. In combustion emits toxic fumes of carbon dioxide / carbon monoxide. Nitrogen oxides (NO_x). Hydrogen fluoride (HF).

5.3. Advice for fire-fighters

6.1. Personal precautions, protective equipment and emergency procedures

Mark out the contaminated area with signs and prevent access to unauthorised personnel. Turn leaking containers leak-side up to prevent the escape of liquid. Eliminate all sources of ignition.

Recommended storage temp 2-8 °C.
