Nitriles may resemble cyanides in toxicity. Exposure to nitriles may cause increased salivation, flushing of the face, eye and respiratory tract irritation, shallow

respiration, nausea, vomiting, weakness, headache and diarrhea. Jaundice, anemia, and leucocytosis has been reported in some cases.
