SECTION 4: First aid measures

4.1. Description of first aid measures

- First-aid measures general : In case of accident or if you feel unwell, seek medical advice immediately (show the label where possible). Move the affected personnel away from the contaminated area.

4.2. Most important symptoms and effects, both acute and delayed

- Symptoms/injuries : The most important known symptoms and effects are described in the labelling (see section 2.2) and/or in section 11.
- Symptoms/injuries after inhalation : Material is destructive to tissue of the mucuous membranes and upper respiratory tract. Cough, shortness of breath, headache, nausea.

4.3. Indication of any immediate medical attention and special treatment needed

Treat symptomatically.

SECTION 5: Firefighting measures

5.1. Extinguishing media

- Suitable extinguishing media : Alcohol resistant foam. Carbon dioxide. Dry powder. Water spray. Use extinguishing media appropriate for surrounding fire.

5.2. Special hazards arising from the substance or mixture

- Fire hazard : Thermal decomposition generates: Carbon oxides.
- Explosion hazard : When mixed with air and exposed to an ignition source, dust may burn in the open air or explode if confined. Risk of explosion if heated under confinement. Use water spray or fog for cooling exposed containers. May form flammable/explosive vapor-air mixture.

5.3. Advice for firefighters

- Firefighting instructions : In case of fire: Evacuate area. Fight fire remotely due to the risk of explosion.
- Protection during firefighting : Wear gas tight chemically protective clothing in combination with self contained breathing apparatus. For further information refer to section 8: "Exposure controls/personal protection".

SECTION 6: Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures

General measures : Evacuate unnecessary personnel. Ensure adequate air ventilation. Do not breathe dust. Do not breathe gas, fumes, vapor or spray.

6.1.1. For non-emergency personnel

Emergency procedures : Only qualified personnel equipped with suitable protective equipment may intervene.

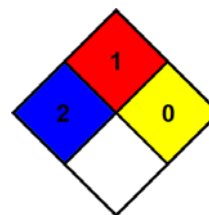
