SECTION 4: First aid measures

4.1. Description of first aid measures

4.2. Most important symptoms and effects, both acute and delayed

- Symptoms/injuries after inhalation : Material is destructive to tissue of the mucuous membranes and upper respiratory tract. Cough, shortness of breath, headache, nausea.

5.1. Extinguishing media

- Fire hazard : Thermal decomposition generates: Carbon oxides. Hydrogen fluoride. Hydrogen iodide.

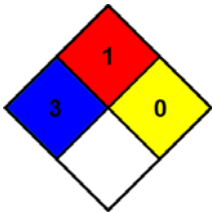
