and stools are bloody and the patient goes into collapse and shock with weak, rapid pulse, cold sweats, coma and death.

Chronic arsenic poisoning may cause disturbances of the digestive system such as loss of appetite, cramps, nausea, constipation or diarrhea.

Inorganic bromides may produce depression, emaciation and in severe cases, psychosis and mental deterioration. Bromoderma, a bromide rash, often occurs when

bromide inhalation or administration is prolonged. This rash is usually found on the face and resembles acne and furunculosis.

Subacute to chronic toxicity: No effects known.
