Prolonged exposure to iodides may cause skin rash, running nose, headache and irritation of the mucous membranes. In severe cases the skin may show pimples, boils, redness, black and blue spots, hives and blisters. Iodides are readily diffused across the placenta.

Vanadium compounds act chiefly as an irritant to the eyes and respiratory tract. Exposure may cause conjunctivitis, rhinitis and reversible irritation of the respiratory tract. More severe cases may cause bronchitis, bronchospasms and asthma like disease. May cause polycythemia, red blood cell destruction and anemia,

albuminuria and hematuria, gastrointestinal disorders, nervous complaints and severe cough.

Subacute to chronic toxicity: No effects known.

Additional toxicological information: To the best of our knowledge the acute and chronic toxicity of this substance is not fully known.
