Section 5. Fire Fighting Measures

General Hazards: In the presence of water/moisture, the product will readily hydrolyze to release hexamethyldisilazane, a flammable liquid with associated flammable vapors.

Suitable Extinguishing Media: THE MOST EFFECTIVE FIRE EXTINGUISHING AGENT IS DRY CHEMICAL POWDER PRESSURIZED WITH NITROGEN. For small fires, vermiculite, sand, dry chemical or carbon dioxide (CO₂) may also be used. For large fires, large quantities of water (flooding) may be applied as a spray or a mist to control the fire and cool affected containers.

Unsuitable Extinguishing Media: DO NOT USE WATER OR FOAM as product reacts to produce flammable vapors upon contact with water.

Unusual Fire and Explosion Hazards: This material reacts with water and compounds containing active hydrogen such as alcohols and acids to produce flammable liquids and gases. Section 6. Accidental Release Measures

Large Spill:

Introductory Remarks:
