Benactyzine hydrochloride is reported to be an anticholinergic agent. Anticholinergic side effects include blurred vision, dryness of mouth or failure of visual accommodation. Additional side effects can include dizziness, thought-blocking, a sense of depersonalization, aggravation of anxiety, disturbance of sleep patterns, subjective feeling of muscle relaxation, gastric distress, allergic response, ataxia and euphoria.

To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated.
