4.1. Description of first aid measures

5.1. Extinguishing media

Extinguishing media: Suitable extinguishing media for the surrounding fire should be used. Carbon dioxide, dry chemical powder, foam.

5.2. Special hazards arising from the substance or mixture

Exposure hazards: Flammable. Forms explosive air-vapour mixture. In combustion emits toxic fumes. Hydrogen fluoride (HF).
