Bismuth compounds are often poorly absorbed. However exposure may cause loss of appetite, headache, skin rash, exodermatitis, kidney injury and jaundice.
Repeated or prolonged exposure may cause a bismuth line or black spots on the gums, foul breath and salivation.
Exposure to bismuth may cause injury to the mouth, esophagus and stomach. Symptoms may include loss of appetite, headache, skin rash, kidney damage and jaundice.
Iron compounds may cause vomiting, diarrhea, pink urine, black stool, and liver damage. May cause damage to the kidneys. Irritating to the respiratory tract, they may cause pulmonary fibrosis if dusts are inhaled.
Subacute to chronic toxicity: No effects known.
