2.1. Classification of the substance or mixture

3.1. Substances

Chemical identity: THALLIUM(I) HEXAFLUOROPHOSPHATE

Section 4: First aid measures

4.1. Description of first aid measures

Skin contact: Remove all contaminated clothes and footwear immediately unless stuck to skin.

Drench the affected skin with running water for 10 minutes or longer if substance is still on skin. Transfer to hospital if there are burns or symptoms of poisoning.

Eye contact: Bathe the eye with running water for 15 minutes. Transfer to hospital for specialist examination.

Ingestion: Wash out mouth with water. Do not induce vomiting. If conscious, give half a litre of water to drink immediately. If unconscious, check for breathing and apply artificial respiration if necessary. If unconscious and breathing is OK, place in the recovery position. Transfer to hospital as soon as possible.

Inhalation: Remove casualty from exposure ensuring one's own safety whilst doing so. If conscious, ensure the casualty sits or lies down. If unconscious and breathing is OK,

place in the recovery position. If unconscious, check for breathing and apply artificial respiration if necessary. If breathing becomes bubbly, have the casualty sit and provide oxygen if available. Transfer to hospital as soon as possible.

4.2. Most important symptoms and effects, both acute and delayed

Skin contact: There may be redness or whiteness of the skin in the area of exposure. Irritation or pain may occur at the site of contact. Absorption through the skin may be fatal.

Eye contact: There may be severe pain. The eyes may water profusely.

Ingestion: There may be soreness and redness of the mouth and throat. There may be vomiting. Convulsions may occur. There may be loss of consciousness.

Inhalation: There may be shortness of breath with a burning sensation in the throat. Absorption through the lungs can occur causing symptoms similar to those of ingestion. Convulsions may occur. There may be loss of consciousness.

Delayed / immediate effects: Immediate effects can be expected after short-term exposure. the most characteristic symptom of thallium exposure is alopecia. Effects may also include dry, scaly skin and impairment of nail growth often resulting in the appearance of crecent-shaped strips across fingernails and toenails (Mees' lines). Acute poisoning results ins welling of the legs and feet, arthralgia, vomiting, insomnia, hyperesthesia and paresthesia of the hand and feet, mental confusion, polyneuritis with severe pain in the legs and loins, partial paralysis of the legs. Angina-like pains, nephritis, wasting and weakness, and lymphocytosis and esinophilia.

4.3. Indication of any immediate medical attention and special treatment needed

Immediate / special treatment: Immediate medical attention is required. Show this safety data sheet to the doctor in attendance.

6.2. Environmental precautions

Environmental precautions: Do not discharge into drains or rivers.

6.3. Methods and material for containment and cleaning up
