It is a central nervous system depressant and ingestion leads to drowsiness, lassitude, loss of appetite and inability to concentrate. Mutagenic and teratogenic data have been reported.

Titanium compounds are considered physiologically inert. There are no reported cases in the literature where titanium as such has caused human intoxication.
