2.1. Classification of the substance or mixture

Chemical identity: 1-BROMO-2-FLUOROCYCLOHEXANE

4.1. Description of first aid measures

5.1. Extinguishing media

Extinguishing media: Carbon dioxide, dry chemical powder, foam. Suitable extinguishing media for the surrounding fire should be used.

5.2. Special hazards arising from the substance or mixture

Exposure hazards: Highly flammable. Forms explosive air-vapour mixture. Vapour may travel considerable distance to source of ignition and flash back. In combustion emits toxic fumes. Carbon oxides. Nitrogen oxides (NOx). Hydrogen bromide (HBr). Hydrogen fluoride (HF).

5.3. Advice for fire-fighters

Advice for fire-fighters: Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin and eyes.
