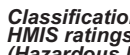

**Subacute to chronic toxicity:**  
Carbonyl compounds are toxic due to decomposition yielding carbon monoxide. Symptoms include asphyxia, headache, mental confusion, dizziness, impairment of vision and hearing, and fainting. High exposures can result in unconsciousness and death due to the inability of hemoglobin to carry oxygen to the tissues. Iron compounds may cause vomiting, diarrhea, pink urine, black stool, and liver damage. May cause damage to the kidneys. Irritating to the respiratory tract, they may cause pulmonary fibrosis if dusts are inhaled. Tungsten compounds may be irritating to the eyes and respiratory tract. Chronic exposure may result in permanent lung damage.  
**Subacute to chronic toxicity:** No effects known.  
**Subacute to chronic toxicity:**  
Organic phosphorus compounds exhibit a wide range of toxicity. Most are skin and eye irritants with the more volatile also being respiratory irritants. Those exhibiting substantial water reactivity will have stronger irritating properties and may be corrosive enough to cause severe burns. Some organic phosphorus compounds are cholinesterase inhibitors. Symptoms associated with these include muscle twitching, convulsions, flaccid paralysis, coma, respiratory failure. They can be highly paralytic.  
**Additional toxicological information:** To the best of our knowledge the acute and chronic toxicity of this substance is not fully known.
