Section 4. First Aid Measures

Description of Necessary First Aid Measures

General Advice: Move out of dangerous area. Call a POISON CENTER or doctor/physician immediately. Show this safety data sheet to the doctor in attendance. If unconscious, place in recovery position and get medical attention immediately. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband.

Eye Contact: Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Rinse for a minimum of 15 minutes. Check for and remove any contact lenses after initial rinse period and continue rinsing for an additional 15 minutes. Keep eyes wide open during rinsing process. Protection of Firefighters:

For Non-Emergency Personnel:

Section 7. Handling and Storage

Precautions:

Keep container tightly sealed. Avoid contact with skin, eyes and clothing. Do not ingest. Avoid prolonged exposure. Ensure adequate ventilation.

Protective Measures:

Put on appropriate personal protective equipment (see Section 8). Keep in the original container kept tightly closed when not in use. Empty containers retain product residue and can be hazardous. Do not reuse container.

General Occupational Hygiene:

Introductory Remarks:

These recommendations provide general guidance for handling this product.
