Corrosive materials are acutely destructive to the respiratory tract, eyes, skin and digestive tract. Eye contact may result in permanent damage and complete vision loss. Inhalation may result in respiratory effects such as inflammation, edema, and chemical pneumonitis. May cause coughing, wheezing, laryngitis, shortness of breath, headache, nausea and vomiting.
