4.1. Description of first aid measures

5.2. Special hazards arising from the substance or mixture

Exposure hazards: In combustion emits toxic fumes of carbon dioxide / carbon monoxide. Borane/boron oxides. Hydrogen fluoride (HF).

5.3. Advice for fire-fighters
