5. FIRE-FIGHTING MEASURES

Ensure adequate ventilation. Isolate the hazard area and deny entry to unnecessary and unprotected personnel. |

6. ACCIDENTAL RELEASE MEASURES**Methods and materials for containment and cleaning up:**

ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). Stop leak if without risk. Ventilate the area. Absorb with an inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material.

Environmental precautions:

Keep away from living quarters. Prevent further leakage or spillage if safe to do so. Water runoff can cause environmental damage. Prevent entry into sewers, basements or confined areas; dike if needed.

Avoid inhalation of vapor or mist. Do not ingest. Avoid contact with skin and eyes. Good general ventilation should be sufficient to control airborne levels. Keep container dry. Handle and open container with care. Wear suitable protective clothing, gloves and eye/face protection. When using do not eat, drink, or smoke. Keep away from sources of ignition.

Conditions for safe storage:

Keep only in the original container in a cool well-ventilated place. Keep away from incompatibles. Containers which are opened must be carefully resealed and kept upright to prevent leakage. Avoid prolonged storage periods. Store under inert gas (e.g. Argon). Hygroscopic material, store in a tightly sealed container.
