Tellurium is converted in the body to dimethyl telluride which imparts a garlic-like odor to the breath and sweat. Heavy exposure may result in headache, drowsiness, metallic taste, loss of appetite, nausea, tremors, convulsions, and respiratory arrest. Reproductive effects in laboratory animals have been reported. Strontium has a low order of toxicity. As with calcium, the toxicity is generally a function of the anion.

Subacute to chronic toxicity: No effects known.

Additional toxicological information: To the best of our knowledge the acute and chronic toxicity of this substance is not fully known.
