The main symptoms of thallium poisoning are peripheral neuropathy and loss of hair. Acute poisoning causes paresthesias, ataxia, alopecia, fever, coryza, abdominal pain, nausea and vomiting. Symptoms may progress to lethargy, speech disorders, tremors, convulsions, cyanosis, pulmonary edema, bronchopneumonia and death. Kidney, liver and brain damage can occur. Thallium poisoning during the first trimester of pregnancy can cause skeletal deformities, alopecia, low birth weight and premature birth. Chronic thallium poisoning may produce alopecia, salivation and a blue line on the gums. Damage to the gastrointestinal, endocrine system and kidneys may also occur.  
Tellurium is converted in the body to dimethyl telluride which imparts a garlic-like odor to the breath and sweat. Heavy exposure may result in headache, drowsiness, metallic taste, loss of appetite, nausea, tremors, convulsions, and respiratory arrest.  
**Subacute to chronic toxicity:** No effects known.  
**Additional toxicological information:** To the best of our knowledge the acute and chronic toxicity of this substance is not fully known.
