2.1. Classification of the substance or mixture

4.1. Description of first aid measures

Section 5: Fire-fighting measures

5.1. Extinguishing media

Extinguishing media: Carbon dioxide, dry chemical powder, foam. Suitable extinguishing media for the surrounding fire should be used. Use water spray to cool containers.

Exposure hazards: In combustion emits toxic fumes of carbon dioxide / carbon monoxide. Sulphur oxides (SO_x).

Mark out the contaminated area with signs and prevent access to unauthorised personnel. Turn leaking containers leak-side up to prevent the escape of liquid.

Clean-up procedures: Absorb into dry earth or sand. Transfer to a closable, labelled salvage container for disposal by an appropriate method.

Storage conditions: Store in cool, well ventilated area. Keep container tightly closed. Air sensitive. Store under Argon. Recommended storage temp 2-8 °C.
