#### Large Spill:

Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. ### Section 8. Exposure Controls/Personal Protection

#### **Introductory Remarks:**

These recommendations provide general guidance for handling this product. Because work environments and material handling practices vary, safety procedures should be developed for each intended application. While developing safe handling procedures, do not overlook the need to clean equipment and conduct regular repairs. Waste from these procedures should be handled in accordance with Section 13.

#### **Occupational Exposure Limits:**

Product contains no substances with occupational exposure limit values.

#### **Engineering Controls:**

Properly operating chemical fume hood designed for hazardous chemicals and having an average face velocity of at least 100 feet per minute. Provide an eyewash/shower station.

#### **Environmental Exposure Controls:**

Emissions from ventilation or work process equipment should be checked to ensure they comply with the requirements of environmental protection legislation. In some cases, fume scrubbers, filters or engineering modifications to the process equipment will be necessary to reduce emissions to acceptable levels.

#### **Individual Protection Measures**

##### **Hygiene Measures:**

Wash hands, forearms and face thoroughly after handling chemical products, before eating, smoking and using the lavatory and at the end of the working period. Remove all soiled and contaminated clothing immediately. Do not inhale dusts produced by product. Avoid contact with eyes and skin. Ensure that eyewash stations and safety showers are close to the workstation's location.

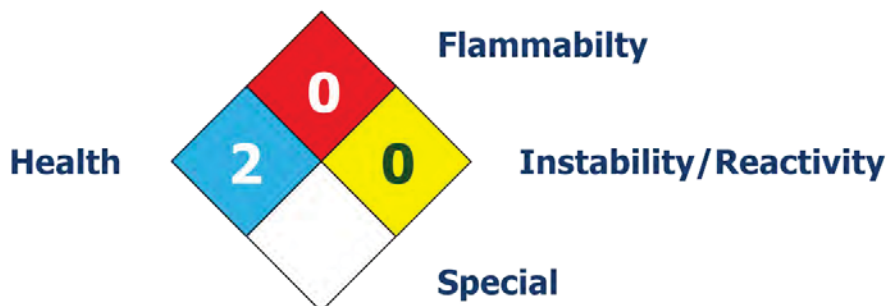
