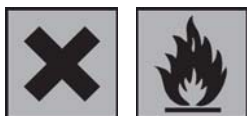

Section 5: Fire-fighting measures

5.1. Extinguishing media

Extinguishing media: Carbon dioxide, dry chemical powder, foam. Suitable extinguishing media for the surrounding fire should be used.

Exposure hazards: Highly flammable. May form flammable / explosive dust-air mixture. In combustion emits toxic fumes of carbon dioxide / carbon monoxide. Metal oxides.

Storage conditions: Store in cool, well ventilated area. Keep container tightly closed. Keep away from sources of ignition. Prevent the build up of electrostatic charge in the immediate area. Ensure lighting and electrical equipment are not a source of ignition. Product reacts with water. Take precautions to avoid contact with atmospheric moisture. Store under Argon.

Suitable packaging: Must only be kept in original packaging.
