5.1. Extinguishing media

Extinguishing media: Carbon dioxide, dry chemical powder, foam. Suitable extinguishing media for the surrounding fire should be used.

Exposure hazards: Flammable. Forms explosive air-vapour mixture. In combustion emits toxic fumes of carbon dioxide / carbon monoxide. Nitrogen oxides (NO_x). Oxides of phosphorus.

Mark out the contaminated area with signs and prevent access to unauthorised personnel. Turn leaking containers leak-side up to prevent the escape of liquid. Eliminate all sources of ignition.
