2.1. Classification of the substance or mixture

4.1. Description of first aid measures

5.1. Extinguishing media

Extinguishing media: Carbon dioxide, dry chemical powder, foam. Suitable extinguishing media for the surrounding fire should be used. Use water spray to cool containers.

Exposure hazards: In combustion emits toxic fumes. Carbon oxides. Nitrogen oxides (NOx). Hydrogen fluoride (HF).
