4. FIRST-AID MEASURES

Inhalation:	Call emergency medical service. Move victim to fresh air. Give artificial respiration if victim is not breathing. Administer oxygen if breathing is difficult. Keep victim warm and quiet. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing (Section 8). Warn unnecessary personnel to move away. Stop leak if you can do it without risk. Ensure adequate ventilation. Isolate the hazard area and deny entry to unnecessary and unprotected personnel.
Personal protective equipment:	Safety glasses. Lab coat. Dust respirator. Be sure to use a MSHA/NIOSH approved respirator or equivalent. Wear protective gloves (nitrile).
Emergency procedures:	Prevent dust cloud. ELIMINATE all ignition sources (no smoking, flares, sparks or flames in the immediate area). Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Warn personnel to move away. Prevent entry into sewers, basements or confined areas; dike if needed.

Methods and materials for containment and cleaning up:

ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). All equipment used when handling the product must be grounded. Stop leak if without risk. Ventilate the area. Absorb with an inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material.

Use explosion-proof equipment. Use only non-sparking hand tool when handling this product. Ground all equipment containing material. Take measures to prevent build up of electrostatic charge. Good general ventilation should be sufficient to control airborne levels. Keep container dry. Handle and open container with care. Wear suitable protective clothing, gloves and eye/face protection. When using do not eat, drink, or smoke. Keep away from sources of ignition.
