Section 5: Fire-fighting measures

5.1. Extinguishing media

Extinguishing media: Alcohol resistant foam. Water spray. Carbon dioxide. Dry chemical powder. Use water

spray to cool containers.

Exposure hazards: Highly flammable. In combustion emits toxic fumes. Forms explosive air-vapour mixture.
