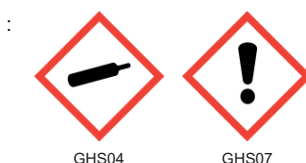

SECTION 4: First aid measures

4.1. Description of first aid measures

SECTION 6: Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures

- General measures : Evacuate unnecessary personnel. Ensure adequate air ventilation. May cause suffocation by reducing oxygen available for breathing. Do not breathe gas, fumes, vapor or spray.
