4. FIRST-AID MEASURES

Inhalation:	Immediately call a poison center or doctor. Move victim to fresh air. Give artificial respiration if victim is not breathing. Administer oxygen if breathing is difficult. Keep victim warm and quiet. Treat symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and take precautions to protect themselves.

Ingestion:	Toxic if swallowed. Do not induce vomiting without medical advice. Call a physician or Poison Control Center immediately. Do not use mouth-to-mouth method if victim ingested the substance; give artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Loosen tight clothing such as a collar, tie, belt or waistband. If a person vomits place them in the recovery position so that vomit will not reenter the mouth and throat. Rinse mouth. Special precautions for fire-fighters:

Use water spray or fog; do not use straight streams. Dike fire-control water for later disposal; do not scatter the material. May re-ignite after fire is extinguished. Runoff to sewer may create fire or explosion hazard. Containers may explode when heated. Move containers from fire area if you can do it without risk.

Special protective equipment for fire-fighters:

Wear positive pressure self-contained breathing apparatus (SCBA). 6. ACCIDENTAL RELEASE MEASURES

Methods and materials for containment and cleaning up:

ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). All equipment used when handling the product must be grounded. Stop leak if without risk. Ventilate the area. Absorb with an inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material.
